


Renewing Your SVPA Membership

(in time for SVPA's 2023 Conference)

In preparation for the upcoming SVPA 2023 Fall Conference, “**From Recovery To Triumph: Healing In The Pandemic Era**,” we need to make sure your membership is current so you do not have to pay the non-member registration fee amount.
